Dear Rep. Bono Mack,

The Alliance for Childhood Cancer, representing twenty national patient advocacy groups and professional medical and scientific organizations, is pleased to support “The Pediatric, Adolescent, and Young Adult Cancer Survivorship Research and Quality of Life Act of 2007” (H.R. 4450). We commend you for introducing legislation that would enhance research and programs for young cancer survivors that will lead to improved health for the growing number of survivors of childhood cancers.

The population of survivors of childhood cancers has grown exponentially over the years. In 1960, only four percent of children with cancer survived more than five years compared to 270,000 survivors of childhood cancers as of 1997. As many as two-thirds of these survivors are experiencing late effects of treatment, and one-fourth experience effects that are serious or life threatening. With so many survivors experiencing these late effects, it is critical that resources are made available to all childhood cancer survivors, especially those in minority or underserved communities. The Alliance welcomes the legislation’s provisions to establish clinics for comprehensive long-term follow-up services for survivors, grants to improve access to care for survivors of childhood cancer, and Centers for Disease Control and Prevention cancer control programs aimed at providing guidance to states and encouraging them to improve systems of care for survivors of childhood cancer.

The Alliance for Childhood Cancer advocates efforts to advance research and policies to improve the diagnosis, treatment, care, and survivorship of children and adolescents with cancer, as well as enhance public awareness. We look forward to working with you and your colleagues to pass this important piece of legislation to help childhood cancer survivors.
